This Day in History... September 22, 1949 **American Business Women's Association**

The American Business Women's Association was founded on September 22, 1949, to bring together business women from all occupations to help each other. Since 1983, this date has been celebrated as American Business Women's Day.

During World War II, women were encouraged more than ever to join the workforce. Posters and propaganda were meant to convince women that it was their patriotic duty to contribute to the war effort by taking on the jobs left by the men who went off to fight in the war. After Stamp paid tribute to American the war ended, many of these women lost their jobs.



In 1949, Kansas City businessman Hilary Bufton Jr. recognized the situation these women faced and acknowledged the benefits expanding women's opportunities in the workforce. On September 22, 1949, he met with business women Shirley Cupp, Irma Beisel, and Frances Stuckey at a local coffee shop. Together they established the American Business Women's Association. Bufton later wrote, "it was my feeling all women were seeking and deserved equal business opportunities. They had gained tremendous knowledge during World War II, through necessity, and I felt a new organization for all businesswomen was needed."

It was uncommon and at the time for women to pursue full-time careers or join such an association. Bufton later recalled, "In many ways, the first

generation of ABWA members were the breaking tradition ... Without even knowing it, I guess they were paving the way for today's women."

The association's first chapter, dubbed the "Pioneer Chapter" was created on November 21, 1949. Four years later, the organization established the Stephen Bufton memorial Education Fund, to help women meet their professional goals with the aid of grants and interestfree loans. Local chapters, individual members, and other people and corporations support this fund. To date, the fund has given out more than \$7.5 million in loans and grants. The association also established the President's Scholarship for its 20th anniversary in 1969. Each year, this \$3,000 scholarship is awarded for graduate study in a discipline specified by the board of trustees. Two more scholarships were introduced in 1986, which are both valued at \$10,000.

The mission of the association is "to bring together businesswomen of diverse occupations and to provide opportunities for them to help themselves and others grow personally and professionally through leadership; education, networking support and national recognition." The organization is open to women in all stages of their careers and all professions - including teachers, administrative assistants, small business owners, and more. There are currently 15,000 members across the country in 400 chapters in all 50 states and over 20 different industries.

In 1983, the first American Business Women's Day was celebrated on From the Celebrate the Century September 22. It was then recognized by a Congressional resolution and

presidential proclamation in 1986, and has been celebrated annually ever since. American Business Women's Day celebrates the legacy and contributions of more than 68 million working women and 7.7 million women business owners. It's also a chance to local chapters and business women to share their accomplishments with their communities and beyond.

ABWA Northeast Sunrise Charter Chapter Standing Rules Approved at General Meeting September 13, 2022

Monthly meetings and membership:

1. Membership meetings will be held on the second Tuesday of every month. Networking begins at 6:00pm. The Call to Order will be at 6:30pm. If a meeting is cancelled for any reason the Executive Board officers will contact the members via telephone and/or electronic messaging.

2. Chapter dues will be \$36 per year due on August 1st, which will cover chapter expenses and approved speaker's expenses.

3. At regularly scheduled chapter meetings, members and guests <u>may choose</u> to purchase three tickets for the 50/50 raffle for \$2. The proceeds from the 50/50 drawing will be added to the Happy Angel \$ account used to sponsor our Christmas Happy Angel Giving.

4. The Secretary's and Treasurer's Reports will be published in the monthly newsletter and voted on for approval by the membership at the next Regular meeting.

5. Guests and prospective members may attend the monthly meetings. Prospective members may attend <u>up to 3 monthly</u> <u>meetings</u> before applying for membership to the National ABWA and the local Chapter.

6. New Chapter members will be given a name badge and membership pin at Chapter expense. Officer pins, purchased at Chapter expense, will be passed on to new officers and past officers will receive a past officer pin at Chapter expense as approved by the Board. If new Committee Chair ribbons are needed, they will be purchased at Chapter expense as approved by the Board.

Awards and Conference:

7. Woman of the Year and Associate of the Year awards will be voted on at the April meeting and presented at the May meeting. Awards will be given at Chapter Expense as approved by the Board.

8. The Chapter will pay the full registration fee for the Woman of the Year and the Chapter President to attend the District Conference. In addition, the Board will determine a maximum expense amount for the Woman of the Year and the Chapter President to apply to expenses incurred at the District Conference. The expense amount will be presented for a vote of the membership each year.

9. The Chapter will recognize "perfect attendance" (October-September) with an award lapel pin presented at the October meeting. Those with just one absence will get special mention. Awards are given at Chapter expense as approved by the Board.

Chapter Financial Management:

10. The Chapter may spend/donate up to \$50.00 in the event of a death of an active member or an immediate family member (spouse, child, significant other, or parent) of an active member. Any other expense/donation (illness and hospital stay) will be at the discretion of the Chapter.

11. The majority of the Executive Board may approve miscellaneous bills up to \$100.00 without a vote of the general membership. The Executive Board will monitor bills from/for special events at the time of the event.

12.The Chapter will pay for the guest speaker's dinner (excluding alcoholic beverages). Any other speaker expenses will need approval by the Board prior to the speaker's appearance.

13. The Chapter will fund an Impact Scholarship through ABWA's Stephen Bufton Memorial Educational Foundation each year. The Executive Board will recommend the amount given based on the success of the Annual Fashion Show. A membership vote to approve the amount the Board recommended will be required. The Scholarship will be awarded at the June meeting of the general membership.

14. The Chapter may recognize and consider for reimbursement, expense requests from members for continuing education including, but not limited to, attendance at District or National conventions. This will be discussed by the Board and must be voted on by the membership.

15. Donations to local organizations require a letter soliciting funding and must be supported by an active Charter Chapter member. The ABWA member presenting the request will clearly identify how the requested funding supports the ABWA mission. All donations will be formally approved by the Executive Board and voted on by the membership.


